ACCESSIBILITY STATEMENT

This website is run by Clayton-le-Woods Parish Council and is hosted by Easy Websites. To meet the Public Sector Bodies (Website and Mobile Applications) Accessibility Regulations 2018 the website was upgraded in September 2020 using the Website Content Accessibility Guidelines (WCAG) 2.1 AA rating framework.

We want as many people as possible to be able to use the website. This means that you will be able to do the following:

Accessibility of the website

We know that there are some parts of the website that are not fully accessible:
