19.27 RECOMMENDATION OF CONTRACTOR FOR CUNNERY MEADOW PLAY AREA

Following the Parish Council Meeting on April 15th options for the delivery of the Cunnery Meadow Play Area were considered.

Under delegated power from the FPC It was resolved to go forward with Option 1, which is the provision of the new play area designed by Wicksteed at the fixed price cost of £65,000.

However the Committee requested that the Clerk speak with the Open Spaces Officer at Chorley Borough Council and Wicksteed to confirm the position of the zipline in the design.

19.28 ANNUAL SCARECROW FESTIVAL PROPOSALS

Councillor G Ormston requested that the Committee agree to progress with the Scarecrow Festival within the parish this year.

The Clerk advised that here had been contact with Whittle-le-Woods Parish Council about combining both Scarecrow Festivals.

The first proposal was to agree to hold the Scarecrow Festival in 2019.

The Committee debated the merits of progressing this and following a vote it was agreed unanimously that a recommendation would be made to FPC to hold the Scarecrow Festival during 2019.

The second proposal was to agree to work in partnership with Whittle Parish Council to hold a joint Scarecrow Festival with up to 3 Councillors representing each parish.

Following an in depth discussion it was agreed by 4 votes in favour and 1 against, to recommend to the FPC to liaise with Whittle-le-Woods Parish Council about combining both the villages Scarecrow Festival's into one event.
