The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

In order to comply with their Code of Conduct, a Member or Co-opted Member (“M”) must register their pecuniary and interests other than pecuniary interests with Clayton-le-Woods Parish Council’s Monitoring Officer within **28 days** of the date of their election or co-option (Failure to declare a disclosable pecuniary interest is a criminal offence).
