

Notification by Members of a Parish/Town Council of Pecuniary and other registerable interests.

Localism Act 2011, Sections 28 &29

The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

In order to comply with their Code of Conduct, a Member or Co-opted Member ("M") must register their pecuniary and interests other than pecuniary interests with Clayton-le-Woods Parish Council's Monitoring Officer within **28 days** of the date of their election or co-option (Failure to declare a disclosable pecuniary interest is a criminal offence).

Important Notes –

You may complete the form electronically but you must print out and personally sign the completed form.

If in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid the risk of not registering something in error.

Disclosable Pecuniary Interests

These are interests if it is of a description specified in regulations made by the Secretary of State and either it is in **your** interest **or** your partner (which means spouse or civil partner, a person with whom you are living as husband or wife, or a person with whom you are living as if you are civil partners) within the following descriptions.

2. 3. Details of any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority –

- a) **under which goods or services are to be provided or works are to be executed; and**
- b) **which has not been fully discharged.**

4. Details of any beneficial interest in land which is within the area of the relevant authority

- a) **The landlord is the relevant authority; and**

 - iii. If that share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
